

COOKIE NOTICE

1) WHAT ARE COOKIES (OR WEBSITES)?

These regulations apply to the following website managed by **Impact HUB Kft. (hereinafter: "Operator" and "Data Controller")**: budapest.impacthub.net

2) INFORMATIONAL SCOPE OF THE COOKIE

When a website visitor visits the website covered by this notice, a small data file called a cookie (hereinafter: "cookie" or "web cookie") is placed on their computer, which can serve several purposes.

The Data Controller uses only web cookies that are necessary for the operation of the website and support sessions, identify individual user sessions, and facilitate the more convenient use of our website.

Some of the web cookies used are only temporary, so-called functional, and disappear when the browser is closed. There are also convenience cookies that are stored on your computer for 1 month so that if you regularly visit our website, your browser remembers the settings you previously used, thereby you do not need to accept our cookie notice every time you visit or regularly set the filtering conditions according to your needs.

3) PURPOSE OF THE WEB COOKIES

Some of the web cookies we use are essential for the proper functioning of the website (session cookies), others serve to facilitate the more convenient use of the website. By recording the visitor's settings and usage habits, they ease navigation on the site and thereby the use of the website.

4) TYPES OF WEB COOKIES

I. Session cookies

Session *cookies* are necessary for browsing the website and using the functions, among other things they allow the visitor to comment on the actions performed on a given page, function or service. Without the use of "session web cookies", the smooth use of the website cannot be guaranteed. Their validity period covers the duration of the given visit, "web cookies" are automatically deleted at the end of the session or when the browser is closed.

II. Convenience web cookies that support use

These web cookies enable our website to remember which mode of operation you have chosen (for example, you have accepted the web cookie notice and according to which sorting method the results in the search result list are displayed). This is done so that on the next visit you do not have to accept the cookie notice again and again or set the sorting principle according to which you want to view the

content displayed on the page. Without the information contained in the web cookies that store preferences, our website may function less smoothly, but can still operate.

The convenience web cookies do not store any personal data; we only store an identification number, which informs the site that the cookie notice has previously been accepted. The convenience web cookie is stored in the client's browser with an expiration date of 1 month.

5) ABOUT SECURITY

It is crucial that the Site Operator does not record any identifiers or passwords, even when web cookies are enabled.

Even if web cookies are accepted, the visitor can safely use the electronic services provided by the site operator.

Impact HUB Kft., utilizing the network infrastructure of the international Impact Hub as a web hosting service provider, ensures that third-party web cookies related to the web hosting service are centrally filtered.

6) CHECKING YOUR BROWSER'S COOKIE SETTINGS, DISABLING COOKIES

Modern browsers allow for the modification of cookie settings. Some browsers automatically accept cookies by default, but this setting can also be changed to prevent automatic acceptance in the future. If modified, the browser will each time offer the option to set cookies.

We would like to alert our visitors that since the purpose of cookies is to support and facilitate the usability and processes of our website, we cannot guarantee that you will be able to fully utilize all functions of the website if cookies are disabled. In this case, the website may operate differently than planned in your browser.
